The Fellowship Committee held their first meeting of 2020 on January 14.

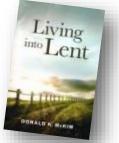

LONG RANGE PLANNING COMMITTEE

Due to COVID-19 and the Church's shut-down, Missions only met in January, March and November. But we kept busy with many projects. Joan Crass resigned early in the year due to health reasons. Dianne Allen volunteered to take donated items and canned goods down to HELPING HANDS periodically. She will continue to do this in 2021.

Sharyl Ritschel resigned in June, so we were one short on the BELLA VISTA PRE-SCHOOL BOARD. This Fall, Joan Dahl offered to fill the spot along with Burnis Leavens.

SOUPER BOWL Sunday in February collected \$1,139.87 for snack packs for the SAMARITAN COMMUNITY CENTER. The snack packs will go to students on Friday so they have something to eat on week-ends.

LENTEN SOUP SUPPERS were cancelled when the Church closed on March 14. We began a canned goods drive for CARE AND SHARE of Gravette when we found out there was no Food Bank there. Several car trunk loads full of canned goods were taken out. Funds in the amount of \$4,750.00 were also collected. They were overwhelmed at the generosity of the Church! These funds will cover Thanksgiving and Christmas this year as well as their needs for 2021.

School supplies were collected in July and August for GRAVETTE SCHOOL STUDENTS. Members took supplies over to the Counselor at Glenn Duffy School for distribution. \$1,574.72 was also given and Missions bought additional items they requested. We have about \$760.00 left.

The ALZHEIMERS WALK in September raised \$1,255.00.

We sent \$500 to Ferncliff Camp where the PRESBYTERIAN DISTRIBUTION ASSISTANCE Center is located to fill Clean Up Buckets for us.

Very few Personal Hygiene bags were assembled by the Sunday School Class this year.

We took a dozen blankets the women made, out to the CHILDREN'S ADVOCACY CENTER for their use.

United Campus Ministry BIKE-A-THON brought \$1,670.00.

Missions and Presbyterian Women will continue collecting personal items and cleaning supplies for ESSENTIALS of Gravette. This helps those on food stamps, since these things are not covered.

An Estate gift to the Church gave MISSIONS 40% (\$6,143.94). We put \$6,000.00 in the Texas Foundation.

Christmas giving this year came from non-budget funds: BRIGHT FUTURES, \$1,200.00; RESTORATION VILLAGE, \$300; HAVENWOOD, \$300; SAMARITAN COMMUNITY CENTER, \$300.

Canned goods were collected for HELPING HANDS for Christmas baskets. Missions gave \$400 for this project. We collected another \$922. We also gave them \$400 in the Spring. Due to COVID we were unable to participate in Work Days this year.

We collected both food donations and cash again this year on the HH table in the Connector hallway and in the church office. Since HH is able to purchase canned good for less than 20 cents a pound, cash donations are a big help.

THE COTTAGES

In 2018 our Church was given a Grant of \$4,000 from the Presbytery of Arkansas to be used in a Community Helping Program. We chose The Cottages of Bella Vista, Arkansas, a HUD Community across the street from the Church.

Due to limited income, the residents chose help with produce. Several residents meet each Monday morning for coffee and visiting. The second Monday of the month, the Produce List is filled out and taken to Allen's Grocery Store nearby. The third Monday someone from the Missions Committee or the Outreach Committee picks up the produce from Allen's and delivers it to the Cottages. It is then sorted and the folks come in and choose what they want. We are grateful for the discount Allen's Grocery Store gives us. There are enough funds in this Grant to provide Produce thru 2021.

Since COVID-19 hit and the Church being closed, it has been difficult, but we have several dedicated folks to see that Produce is delivered each month. The folks at the Cottages look forward to the produce each month. They are most grateful for this program.

Someone from our Congregation has donated funds for meat for the Cottages. Meat was provided several times in 2020, and we have funds for meat in 2021.

UPDATE FROM LARRY & INGE STHRESHLEY, MISSIONARIES

Dear Friends,

Larry and I wish you God's peace and his many blessings. Thank you for your prayers and your financial support this year that have enabled us to work here in Congo and for journeying with us. It has certainly been a challenging year for all of us as we have experienced this global COVID pandemic!

The first week of January, our daughter Lisa came to Kinshasa and we were all together for a few brief days (just missing Hugh). All this family time brought much joy to this mother's heart!!



I am so glad we had that time together at the beginning of the year. I hold on to those good memories as this has been a challenging and rough year. With the COVID pandemic and the boarders closed to international travel in the summer, we had to close the Methodist Presbyterian guesthouse and layoff the staff. Soon afterwards our good friend Clay Dunn, who helped manage the guesthouse and who was doing renovations and maintenance, died from complications from malaria and dengue fever. Even as we celebrate his life and service, we are still grappling with his loss. Clay and his wife Cindy, who returned to the USA, have left a big hold in the hearts of many here in Congo.

Our face-to-face interactions with friends and colleagues has been limited due to the COVID pandemic. The closure of the airports and limited charter flights out of Kinshasa in the early months of the pandemic heightened our sense of isolation. Like many of you, we have been working mainly from home and have had to get use to a more "online" work style. Through UKAID funding, IMA has been able to support 15 health zones in Kinshasa serving 4 million

people to receive and treat COVID patients. As in much of the world, the number of cases here in Kinshasa are increasing. IMA also received a one-year extension from UKAID for the ASSR health program that supports the Congolese Ministry of Health in delivering medical care to around 10 million people in 50 health zones. Needles to say, the COVID context has made carrying out this program more complicated.

So, it has been a year of losses and unforeseen challenges, but also a time to reflect on what is import and a time to find new ways of doing things and new opportunities. As the saying goes, "sometimes you just need to get out of the boat and play in the river" and enjoy the journey. So, we are going to take a break and do just that!

May you experience God's peace and joy and know his rich provision in 2021!

MISSION QUILTING GROUP

With the Coronavirus rearing its ugly head in the spring, we have not met as a group. We keep in touch, however, and have managed to keep really busy. There were a few quilts left over from our 2019 efforts and those were taken for delivery to Vera Lloyd House in February. In all, 11 quilts were taken at that time.

We were told of a need for comfort quilts at the Grove Dialysis Center and in all made 40 quilts. They were greatly appreciated as the facility is kept really cool and the patients chill easily. The quilts were given to individuals as needed. The group will continue to make these quilts, some with batting and some without. There is another facility in Bentonville also in need.

Toward the end of the year, David and Florence Riter made a trip to Little Rock, taking 32 finished quilts with them for delivery to Vera Lloyd House.

In total, the quilting group made 40 comfort quilts and 43 quilts for Vera Lloyd. Isolation makes for productive hands! This work will continue in 2021. We will also be donating some quilts to the Children's Advocacy Group. These will be slightly smaller quilts instead of bed-sized quilts. There is a need for something to wrap around a child when it needs comfort.

Brenda Youngblood of Diamond, MO, continues to do our quilting. She does lovely machine quilting at a very reasonable rate for the church.

There is donated fabric at the church, but many member of our group use their own stash of fabric to make these quilts. The only cost to the church is for the batting and the actual quilting on most quilts. We enjoy making these quilts, knowing they are going to worthy causes.

WORSHIP COMMITTEE

2020 was marked by two events, each having a significant impact on our church, our worship, and this committee's responsibilities—the COVID-19 Coronavirus pandemic and the planned retirement of Rev. Dennis Ritchie in June after 12 years as our Pastor.

On March 14, following the recommendation of the Arkansas Department of Health Guidelines for Places of Worship, Session approved closing the church to in-person worship, meetings, and other church activities until at least April 5. The March 15 worship service was canceled, but beginning on March 22, modified worship services were recorded in the sanctuary on Thursday mornings and posted by Saturday to our website and Facebook page. In addition to Rev. Ritchie, worship leaders included Gail Knudsen (organ and piano), Music Director Stephen Knudsen, Christy and Bud Clark, Lon Cross, and Mary Nimis-Tysk (choir), Ruth Lawson who handled the iPad teleprompter and camera, and Jim Prince who recorded, edited, and posted the service. At their April meeting, Session extended the closing through the end of May.

Initial preparation for an eventual return to in-person worship was begun by Rev. Ritchie in May, including the purchase of communion kits and three no-touch temperature devices. He also marked the pews with painter's tape to designate 6-foot safe-distanced seating. The women's sewing group sewed masks, and Bernie Hietbrink made three additional wooden stands to hold bulletins, offering plates, and hand sanitizer. The Worship Committee met on May 26 to determine what additional preparation would need to be put in place. A One-Call survey was taken to gauge the congregation's willingness to return, and at the June 13 meeting, Session extended the closure until Sunday, September 6.

Rev. Ritchie postponed his retirement from May 31 to June 30. His final service was held and recorded on June 24 for posting on Sunday, June 28, with General Presbyter Reverend Stewart Smith conducting the Dissolution of Pastoral Call liturgy. Dennis was also recognized with the presentation of a painting done by David Rew and a quilt made by our Women's Quilting Group.

Church members Reverend Joe Tropansky and Reverend Dr. Ronnie Prevost agreed to provide pulpit supply on alternating Sundays from July 5 through December 27. Session approved this at their July 11 meeting.



Preparation for re-opening began in earnest at the July 28 Worship Committee meeting. In advance of the meeting, Moderator Jean Nichols first consulted with Rev. Kade Curry (First Presbyterian Church in Springdale) for advice and recommendations for reopening safely. She prepared an

initial draft of a planning guide and COVID guidelines based on Springdale's experience, for the committee to review prior to the meeting. The committee made preliminary decisions regarding safety protocols. Jean updated the reopening plan and sent it back to the committee for review prior to presenting it to Session at their August 8 meeting.

On August 8, Session approved Sunday, September 13 as the first in-person worship service. Elders Bev MacDonald, Elaine Jones, and Jim Prince volunteered to join the Worship Committee's next meeting to assist in planning and preparing. Linda Ervin, Kay Burroughs, and Ron Burroughs also volunteered to participate.

The joint Worship/Reopening Committee met on August 18 to finalize the reopening plan which included guidelines or procedures for

- making reservations to keep numbers within safety guidelines,
- entering via Fellowship Hall to allow for distancing. The Narthex entrance would be open for those who needed assistance,
- velcome/check-in tables in Fellowship Hall and Narthex for taking temperatures, and signing in for attendance and contact tracing, should it be necessary.
- ♦ COVID signage on entry doors and in the building,
- the number of volunteers needed to serve at the welcome tables, and as greeters and ushers, Communion, Passing the Peace, hymn-singing, and entering and exiting the sanctuary and building safely.

A letter explaining the reopening procedures with a copy of the COVID guidelines was mailed to each church member, affiliate, and friend, and both were posted on the PCBV website. The committee scheduled a follow-up meeting for September 22, after two in-person worship services had taken place, for feedback and to make any needed adjustments. A copy of the letter, COVID guidelines, reopening plan, and instructions for Greeters, Welcome Tables, and Ushers has been placed in the Worship Committee Minutes binder in the church workroom.

During the week of September 7, volunteers removed Bibles and hymnals from the sanctuary to store in Classroom C, taped x's on the floors from the Fellowship Hall entrance to the sanctuary to indicate safe-distancing for moving about the building, set up the Welcome/Check-in tables, and posted signage. Orientation sessions were held for the various volunteer teams (Door Greeters, Check-in Table greeters, Sanctuary Greeters, and Ushers) on Friday, September 11 so we would be ready for a smooth and safe re-opening. We determined that it was wise to be meticulous and scale back when it was safe to do so.

Our first in-person, live-streamed worship was on September 13. Recordings continued to be posted to our website for on-demand viewing. At the September 22 Worship Committee follow-up meeting, feedback was mostly positive. There were some initial audio issues with live-streaming that were remedied, and adjustments were made over the first several months, based on viewer feedback, to improve the experience for those worshiping from home. Attendance remained at a safe and reasonable level each Sunday, ranging from a high of 66 to a low of 32, including volunteers and worship leaders. Attendance dropped off slightly beginning in November. With very few exceptions, the congregation followed the safety guidelines carefully, and no COVID cases were reported as of the writing of this report. Because the congregation followed the guidelines closely, and as precautions became habitual, we were able to reduce the number of volunteers from 12 to 8 in November.

Other items to report:

Communion in January and February was celebrated as planned on three Sundays that included home communion, and by intinction at the Ash Wednesday service on February 26. Jerry August took on the role preparing the elements this year and scheduling elders for serving communion though the March shutdown. Other than canceling all home communion visits, communion continued to be celebrated as scheduled through the shutdown, with modifications for safety. In July, Rev. Dr. Ronnie Prevost was given authorization by the Presbytery Committee on Ministry (COM) to administer communion. In October, upon recommendation of the Worship Committee, the Session approved changing the communion schedule to once per quarter until the pandemic ends, using Communion kits instead of bread and juice. Communion on Christmas Eve was celebrated using the kits instead of by intinction.

Guest preachers in 2020 included Ali Wycoff (student, United Campus Ministry) on February 9, Joel Gill (Ferncliff Director, via video) on April 19, Reverend Leslie Belden (First United Presbyterian Church, Fayetteville) on May 31, Reverend Becky Purcell (former pastor, First Presbyterian Church, Prairie Grove) on November 8, and Ron David (Commissioned Ruling Elder) on December 13.

Other items of interest include:

- 1. 14 silk poinsettias, ribbon, and other Advent decorations were purchased in January, taking advantage of post-Christmas sales.
- 2. Vacation pay for the organist position was recommended by the committee and approved by the Session (One day per three years of service).
- 3. Students from United Campus Ministry led our worship service on February 9.
- 4. In April, the Property Committee, led by Darrell Maples and Jim Prince, upgraded the sound system and speakers in the sanctuary.
- 5. To prepare for live-streaming worship services, the Property committee installed a camera and new projectors on August 11, added Cox Wi-Fi in the sanctuary on August 17 in order to have adequate bandwidth, and purchased a new laptop. A monitor was mounted at the rear of the sanctuary in December to assist pastors and liturgists to synchronize elements of worship with the Easy Worship slides.
- 6. Mary Ann Partridge purchased white roses for the Moment of Remembrance service to honor 16 members and church family who died during the past year.
- 7. Advent decorations were scaled back in the sanctuary and eliminated in the church building except for the outdoor wreaths and one poinsettia each in the Narthex, office lobby, and Fellowship Hall. (Decorating committee: Shirley Olson, Terry Woods, Ami Maples, and Peggy Prevost)
- 8. The Thanksgiving and Christmas services and potluck dinners were canceled.
- 9. Our Christmas Eve service was held at 4:00 and without the traditional candle-lighting, due to physical distancing guidelines.

We end 2020 with sincere gratitude to those who gave so much of their time to provide meaningful worship—both in-person and online—under such challenging conditions. These include Reverend Dennis Ritchie, Reverend Joe Tropansky, Reverend Dr. Ronnie Prevost, Stephen Knudsen and the choir, Gail Knudsen, Jim Prince, Becky Morgan, and Ruth Lawson. We thank the elders who served as liturgists this year: Carolyn Pickell, Bev MacDonald, Darrell Maples, Elaine Jones, Nancy Skinner, and Barb Tropansky.

Members of the Worship Committee in 2020 were Jerry August (co-moderator), Burnis Leavens (secretary), Ruth Lawson, Marinell Anderson, Stephen Knudsen, Darrell Maples, Ami Maples, Karen Schneider, Mary Ann Partridge, Shirley Olson, Pastor Dennis Ritchie; and Rev. Joe Tropansky and Rev. Dr. Ronnie Prevost who attended meetings after Dennis's retirement. The committee thanks Burnis Leavens for serving as our committee secretary for many years and as the Clerk of Session for the past 13 years and Jerry August for his leadership as the moderator and co-moderator of the Worship Committee from 2018-2020.

Seldom were we able to meet face to face with the members whom we tried to serve. Assistance in transportation was greatly reduced and the telephone became our primary vehicle of communication. Cards and notes were used to communicate when our members were not able to use the phone. That said, each Deacon is assigned 2-4 people and we average 35-40 members of the congregation each month who are residents of care centers, hospitalized for health concerns, including surgery, or have lost a family member. Any member of the congregation who would like to be assigned a Deacon, or feel the need to have a minister call on them, are urged to call the Church office or call (479) 685-9130 for our "on call minister". Too often we find out we have not been available to help someone who really needs us, because we didn't know about their concerns.

Each of our Deacons are dedicated to be a source of comfort to those who are ill, mourning a love one, or just can't make it to church regularly and feel the isolation associated with our new norm. We all need each other so utilize us when we can be of service.
