# "A cheerful heart is good medicine" Proverbs 17:22a

How shall I reflect on one year with you? At the beginning of January, 2022, I did not know that we would as a session downsize or enjoy dialogue with a new book. We spent many months as elders working through *How to Lead When You Don't Know Where You're Going* by Susan Beaumont, a leader and educator I knew from my time in Michigan. - Helping to hire Paul Bennett and Ann Davidson and saying goodbye to Ruth Lawson as Administrative Assistant and Becky Morgan as Church Secretary.
- Trying Taize as a community for Lent.
- Designing a Holy Humor Sunday with a *Play Ball!* theme! Laughter is also the best, and free, medicine.
- Writing and securing a \$5,000 Presbytery grant last May so that we can start our own Podcasts. Thanks to all those who have participated in this new adventure – it takes an open approach to the ways we communicate and have faith to "put our voices" out there. Thank you to Elaine Jones, Jean Nichols, and Paul Bennett for your gifts and knowledge. I've enjoyed the challenge. We hope you enjoy the product of our work.
- Encouraging open and respectful communication and dialogue, setting healthy expectations and boundaries with staff and session.
- Bike-A-Thon for UCM. Former Pastor Dennis and I rode our 30 plus miles and the church raised close to \$2,000 for United Campus Ministry.
- Leading classes on the Parables of Jesus, Freeing Jesus and a Narnia Advent devotional class was fun. Join us! The conversations can be life-changing.
- Preaching each week with stories and teachable moments which I am hearing are adding meaningful dialogue to your lives.
- Enjoying two Study Leaves where many books were read and worship shared at Ring Lake Ranch and Zephyr Point for clergy renewal.
- Reorganizing session, working on stewardship, developing ways to communicate needs and joys as leaders during our stewardship lunch.

Thank you for sharing with me your personal lives and interests. We have much to be thankful for at PCBV. We are journeying during a time that can feel chaotic given many of the world's issues and needs but we also have a safe place here to meet God and search inside our souls.

When I have visited in hospitals and homes, shared in communion in worship and in homes, listened at Deacons and Session and committee meetings I find energy for trying new things even though the new might bring change. My advice for the coming year is simple: be gentle with leaders. We are working to bring the best gifts in service to God and this congregation.

Gentleness is how Jesus accepted so many hurting people.

Gentleness and kindness with self and others costs nothing.

To love our neighbors as ourselves is really an extension of the love we carry inside, share with our self, and extend to others. It begins with our perspective. So also, gentleness with self is a good first step to how we treat those around us.

One last story.

As we caroled at the Cottages this past December, Sue Predl set up a wonderful and inviting table with goodies and warms drinks. The 6 of us who caroled met those who live at the cottages who wanted fellowship. They repeated how thankful they were to the church for our food ministry and for the care Sue brings to show up and be there for them.

PCBV is a caring community. Let us shine that light always.

#### CHRISTIAN EDUCATION COMMITTEE

Nine people started 2022 as members of the Christian Education Committee. We ended with eleven members.

Our first endeavor was to participate in "Join Up In January" event. Two tables and an easel were used to display our present projects and encourage church members to sign up, give or ask questions as they ate popcorn.

At our January meeting, Elaine Jones had all the details in place for members of both the committee and congregation about getting a background check then reading with or to children at the Boy's and Girl's Club of Bella Vista. Elaine had started the groundwork for this activity in 2021. She continued its supervision through 2022.

In February 10 people toured the Boy's and Girl's Club. Readers had already started reading with children. Background checks were slow coming in since that had to be initiated through the Bentonville office. An idea for "Did you know?" announcements to be given on random Sundays was suggested. These would help let those viewing from home as well as the congregation know about activities being planned.

Since the nursery is for infants through pre-school ages. As of May 29, 2022, Marti was no longer employed by the church. She was given proper notice and a monetary gift for her years of service. In a meeting with the grandparents of our one youth, they stated that without more children, their grandson is not interested in attending. No youth classes will be offered at this time. The youth classroom and the nursery were cleared of the items no longer needed at this time. Most were disposed of at the "Church Treasures" sale.

An adult Sunday morning class was held in Classroom A at 8:30. Attendance was from 15-20. Classes were taught by Bill Wellner and Peggy Prevost on alternating months. Christian Education paid for the study books. A Zoom class was also held most of 2022. Gary Stumbo and Elaine Jones were the contact people.

Four book studies were held in 2022. The books were Advent in Plain Sight, Freeing Jesus, Short Stories by Jesus and Advent in Narnia. Classes were all taught by Pastor Judi McMillan. Books were provided by Christian Education at no cost to those who attended. Attendance was approximately 20 for each study. A watercolor workshop was offered in November. Seven people attended.

Entry forms will be distributed early 2023 for a musical competition planned for March. Stephen Knudsen is the coordinator.

#### **COMMUNICATIONS COMMITTEE**

The PCBV website saw a complete overhaul in 2022. In late February, Pastor Judi initiated a new website with the help of a new church member. During initial discussions regarding the website, it was determined that a new branding effort could be developed in parallel with the website. Through the entirety of the project, time was taken to establish a unique PCBV design standard which would be deployed across the web, print, and video mediums. Simultaneously, Pastor Judi secured a grant which allowed the church to acquire hardware for podcasting which would be featured on the new website.

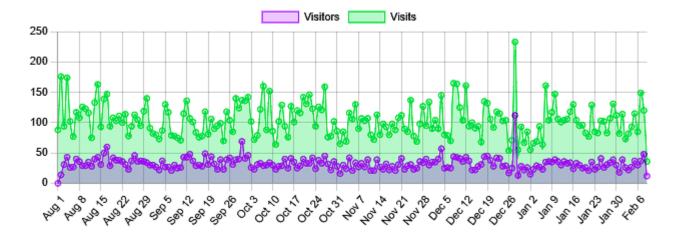
Once the new website was deployed in early June, renewed activity began to overwhelm the server's resources so a migration to a more robust host began in July. Dreamhost was chosen as our new host and PCBV now enjoys vastly greater bandwidth and stability than ever before; at the same price-point as the previous host.

Like it's predecessor, the current PCBV website uses WordPress. WordPress is a content management system which allows us to add rich media content and complex functionality on an as needed basis in the form of plugins. The new site now uses statistical plugins to help measure traffic the site receives, among other end user metrics.

According to data gathered by our system, pcbv.org received, at the time of this report, 5,932 unique visitors generating 23,165 page hits across the entire site since August 1, 2022 to January 29, 2023.

When matters of the website and its reach are concerned, we are making seen the mission of our church to people in various countries.

While the membership of the church is under 200 members, a cursory examination of our online visitors suggest we are reaching many people across the globe. The bulk of these individuals are from the USA.

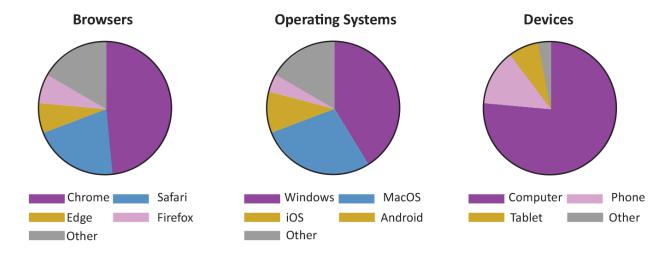

#### **Metrics**

Among other interesting metrics, we have determined a few things about our user's preferred operating systems, browsers, and hardware devices to view our website.



Chrome is the most popular browser viewing pcbv.org
Windows users represent almost 50% of the hits to pcbv.org
Desktops & Laptops are the primary hardware platform for viewing pcbv.org

The previous website had roughly 10 pages of content. In six months, the site has grown to 30 pages and 24 blog posts, many of which include rich-media.

Additional site features to date include:

- Audio/Video Player
- Embedded Live Streaming
- Video Archive
- Prayer Requests
- Bug Reporting
- Member Surveys

Annual expenses for the website cover hosting costs, which are well under \$1,000. In 2023 the hosting costs will be reduced as 2022 briefly saw PCBV paying for two hosts (Tanner Creative and Dreamhost). All design and technical services are provided for free, as part of an informal design & technology mission that reports to what is now known as the Operations committee.

With the refresh of the pcbv.org website, we stand confidently among other churches on the internet. New content is constantly being generated and added to the site. Not content to rest with these achievements, improvements to pcbv.org will continue throughout 2023 and beyond.

#### Future site additions include:

- Historical timeline of PCBV from inception to current state.
- New member photos which will be deployed in various PCBV specific pages & documents.
- New Podcasts.
- New media for various church departments, missions, and activities.
- Tighter branding initiatives with live broadcasting (titles & station id, etc).

#### **New Logo**

Presbyterian Church of Bella Vista has long leveraged the national PCUSA seal. There were no

rules prohibiting us from developing our own seal so a unique logo was designed, inspired by various church iconography.

A font was chosen for use with the PCBV logo and related media. That font is called Cardo, which is free from Google. Cardo is a large Unicode font specifically designed for the needs of classicists, Biblical scholars, medievalists, and linguists. It also works well for general typesetting in situations where a high-quality Old Style font is appropriate. Its large character set supports many modern languages as well as those needed by scholars. Cardo also contains features that are required for high-quality typography such as ligatures, text figures (also known as old style numerals),



true small capitals and a variety of punctuation and space characters. Cardo is used extensively throughout PCBV media including Sunday bulletins, the website, and PowerPoint presentations. Cardo was designed by David Perry.

Our new visual design identity reflects the commitment to excellence that the Presbyterian Church of Bella Vista is well known for. We hope to introduce more design elements into other areas of the church as time and budget allows.

#### **CANOPY NWA**

Canopy is a subcommittee of the church's Missions Committee and is charged with overseeing the needs of Canopy NWA, our church's resettlement partner located in Fayetteville. They are part of a worldwide effort and our work with them focuses on assiting refugees arriving in Northwest Arkansas.

The refugees who are resettled in Northwest Arkansas are immigrants to the United States who come to live here permanently from another country. They go through a very rigorous, years-long process before ever stepping foot in our country. They apply for and are granted refugee status while outside the United States, travel here at the invitation of the US government and have full legal status from the moment they arrive. In most cases this process takes years, and the refugees spend that time in camps in various parts of the world. They are the most closely vetted type of immigrant the US receives.

While the resettlement of refugees in NWA is an ongoing process, the needs fluctuate depending upon the number of refugee families received on a monthly or quarterly basis. The congregation had two opportunities this year to donate to Canopy, both financially and for Welcome Kits. In April we also collected furniture for newly arriving refugees. These events were well received by the congregation and much appreciated by Canopy NWA.

Canopy NWA is blessed in that they receive support and Welcome Kits from several churches in Northwest Arkansas. However, their storage space in Fayetteville is limited and mid-year they asked that collection of Welcome Kits be suspended due to lack of storage space. Financial assistance continues to be needed and is always appreciated.

The Committee appreciates the support this congregation has shown Canopy NWA and will continue to monitor their needs. Committee members include: Marcia Beard, Vicki Erickson, Jan Halgrim, Burnis Leavens, Mary Nimis-Tysk, Peggy Prevost, David Riter, Florence Riter and Pastor Judi.

#### **MISSIONARIES**

Larry says "experiencing the wonder of being part of God's plan" motivates his ministry in the Democratic Republic of the Congo.

Larry & Inge began their amazing journey of mission service more than two decades ago. Over the years, Larry has moved from helping the church manage a handful of clinics in Kinshasa to creating one of the largest church-run health programs in Africa. He has assisted the government in providing medical care to more than 9 million people in 870 health centers and 50 hospitals in four provinces of the country. The impact of Covid-19 has been hard on the Congo where the population is young compared to western countries. About 65% of the population is under 25. Only 2.7% of the population is over 65. But there are a significant number of adults with diabetes and hypertension, as well as thousands of vulnerable children who suffer from acute and chronic malnutrition. When the government authorizes drug treatments, the funds are used to supply drugs to the health centers and hospitals. Kinshasa, the capital city is a priority for UKAID, so the

Covid-19 response includes health facilities in Kinshasa, covering 40% of the population. The nine health facilities managed by the Presbyterian Community of Kinshasa will receive assistance through this Covid-19 funding.

Trained in tropical agriculture, Inge works with the Access to Primary Health Care project (ASSP) and the CPK to address the problem of malnutrition through nutrition education and home gardens and through efficient and low-emission cook stoves. She has written several brochures and a book on agriculture.

The Sthreshleys appreciate Congo's mission heritage as well as the vibrant Christian movement that resulted from those early missionary efforts. Their work models the long-term commitment that historically has characterized mission service. Yet both of them enable the work of Christians who come to Congo on short-term assignments. Which is a priority of their ministry. Presbyterian Women have been especially active in starting and supporting projects in Congo.

Larry holds a doctorate in international health systems management from Tulane University, as master's degree in public health from UCLA, and an undergraduate degree in public health from the University of North Carolina. Inge studied tropical agriculture at the University of Hawaii, where she received a bachelor's degree.

The Sthreshleys are the parents of two children, Lisa and Michael. Lisa was born at the Presbyterian-supported Good Shepherd Hospital in Congo. She is married. BIRTHDAYS: Larry-March 15; Inge-May 24; Lisa-August 8 and Michael-December 4

The year started with eleven Deacons. By May, we lost two Deacons because of health issues. In June we welcomed three new Deacons to bring us to twelve Deacons. In the Fall two more Deacons left because of health issues but we have a full slate of 4 for the Class of 2025. The Deacon of the Month led the group in devotions and prayer and attended the Session meeting to increase communication with the Elders.

The Deacons participated in the "Join Up" Sunday in January, with a table in Fellowship Hall, to provide information about serving as a Deacon.

An information sheet for the local Courtesy Van and Faith in Action was created and inserted in the bulletin in order to make all members aware of their services to homebound individuals. In February the Deacons attended a half day Elder and Deacon Officer Training at church and were encouraged to look outward from our comfort zones.

In March, we challenged our comfort zones by reporting our concerns of our assigned members on a Google Doc. All Deacons could enter their information on this spread sheet on the computer and it would immediately be available for only Deacons and Pastor Judi giving more immediate feedback.

In May we started using the Deacon Primer by C.J. Malone to help us expand our pastoral care skills.

In August we initiated a Contact Information Form to be used with our assigned member in order to have pertinent contact information that could be used by the Deacon or passed on to a new Deacon. Copies of the form are kept in the church office.

During this year the "Watched and Confined" list of members needing assistance has fluctuated. There have been 38 individuals or couples on the list this year. The Deacons met regularly with assigned members who were home bound, had recent medical issues or lost a loved one.

Deacons have offered assistance with moving, driving, meals, delivering gift bags in December and needed friendship. Home Communion to home bound members was offered every quarter to those in Bella Vista, Bentonville and Rogers.

#### PRESBYTERIAN WOMEN

Presbyterian Women of Bella Vista offer a variety of ways for women to live out their faith in an inclusive, caring community that strengthens the Presbyterian Church.

We are now in the second year of our Bible Study group (formerly made up of Rebecca, Martha Garvin and Lydia Circles) and our attendance has been very good. This group meets the second Thursday of the month at 1:00 p.m. in Fellowship Hall. This year's study is about Celebrating the Sabbath and all PW women are invited to attend.

In addition to our Bible Study, the group holds four luncheons each year. The Fall Luncheon is held in September, the Christmas Tea in December, the Spring Luncheon in March and Birthday Luncheon in May. Every two years, the women select two individuals to receive an Honorary Life Membership to Presbyterian Woman in the Presbyterian Church (U.S.A.) Inc. This award recognizes the individuals for her work and dedication to our church and is awarded at the May Luncheon.

As an organization, Presbyterian Women contribute to many local missions serving women and children of Northwest Arkansas. All the funding for projects come from the women of the church. We do not receive any funding from the church budget. PW collect two special offerings each year. The Thank Offering is collected in November and the Birthday Offering in the spring, which supports projects in Arkansas and around the world. This year, we collected \$1,010.00 for the Thank Offering and \$740.00 for the Birthday Offering. Our CentsAbility dollars of \$283.00 will help to raise awareness and funds for the fight against hunger and poverty.

Our women are also active at the state and national level. Vicki Erickson attended the Synod of the Sun Gathering this past July in New Orleans. Synod of the Sun is comprised of churches from 5 states (Arkansas, Oklahoma, Texas, New Mexico and Louisiana). The next PW Synod meeting will be held at First Presbyterian Church in Fayetteville in 2025. There are PW Gatherings held every year on a rotating triennial basis: Church wide, Synod and Presbytery. This year's Gathering will be held at Ferncliff Camp and Conference Center in April and is a Presbytery-wide one. Next year (2023), there will be a Church wide PW Gathering in St. Louis. Also, Vicki has been serving on the Coordinating Team for the Arkansas Presbytery for the last several years.

Busy Hands is a group of ladies who knit and crochet items for missions. This group meets every Friday at 1:00 p.m. in the Church lobby. Currently, the group is working on hats, scarves, mittens and blankets for Knitting4Peace, an organization based in Denver that distributes these items around the world. Our quilting group continues their work by donating quilts to the Vera Lloyd Home to be given to young people who enter the home. Most recently, we have been sending some of our items directly to an organization that distributes them to Romania where Ukraine refugees are being helped.
