Stated Session Meeting Minutes - September 9, 2023

The Session of the Presbyterian Church of Bella Vista, AR held a Stated Session Meeting on Saturday, September 9, 2023 at 9:00 a.m. in Classroom A. Rev. Dr. Judi McMillan called the meeting to order, lit the Christ Candle and welcomed those present. Opening devotion and prayer was given by **Mack Bean.**

<u>Special Order:</u> Mack Bean introduced **Patricia Slaton** and **Jerre Lender** to the Session as a new members. They will be introduced to the congregation on Sunday, September 10. **Patricia** is being received by Transfer of Certificate of Membership and **Jerre** is being received by Reaffirmation of Faith. **Motion to accept was approved.**

<u>Approval of Agenda:</u> Pastor Judi asked if there were any changes, omissions, addition to the agenda. There being none, agenda was approved

<u>Pastor's Reports:</u> Pastor Judi reported she and Jean Nichols will be attending the Advent Workshop in a few weeks at First Presbyterian in Springdale and invited anyone else who might be interested to attend. Pastor reminded the Elders of NWA Elder and Deacon training that will be held at the First Presbyterian Church in Bentonville. Training will be on Thursday, October 5, 2023 from 6:00 p.m. to 8:00. A dinner will be served.

Motion was made, seconded and approved by all Elders attending to allow for Pastor Judi to take the final days of her vacation. Those days are October 21-24, 2023. **Rev. Joe Tropansky** has agreed to preach on Sunday, October 22.

<u>Deacon's Report:</u> A Deacon was not present but Pastor Judi, having attended the Deacon Meeting, reported that it has been brought to the Church's attention that on a recent occasion a distant family member was not able to reach staff on the weekends. It was decided that Pastor will add her cell phone number to our bulletins and suggested to all members that they make next of kin aware of this, perhaps even giving the next of kin the necessary numbers.

Pastor also reported that one day last week a gentleman stopped, saw Tom Hackleman and Paul Bennett out by our sign and gave them a check for \$500.00. The gentleman said he could not get on our website but assumed we still needed money for projection system. Pastor wrote and thanked the gentleman.

<u>Treasurer's Report</u>: Cathy Rew opened her report noting that for July and August, receipt of pledges were down and that the Church should anticipate a \$13,000 short fall for this year's pledges. This is due to church member deaths and/or relocations.

Cathy informed Session that preparation of the Budget for 2024 will be handled differently than in past years. Our Accountant, Ann Davidson, will be responsible for preparing the budget. Each committee lead was asked to meet with Ann before the October Session meeting to discuss and set budgets. Ann will combine the information to be presented to Session for approval.

<u>Clerk's Report</u>: Sharon Warner asked for a motion to approve the Stated Session Minutes of August 12, 2023. There was one correction to be made. **Motion was made, seconded and approved** to approve minutes as corrected.
