OPERATIONS / STEWARDSHIP AND FINANCE

The members of Session received an income and expense report in their Session packet each month from Church Accountant Ann Davidson, as well as a financial status update from Church Treasurer Cathy Rew during Session meetings. The church received two matching grant donations this year. Paul Bennett ran a power point of pictures and graphs throughout the program, the Fishes & Loaves ladies assisted with set-up and serving, and several attendees stepped up and helped with clean-up afterwards. It was an inclusive, church members helping church members event – and all the help was very appreciated!

Ann Davidson worked diligently with all three committees – Operations, Spiritual Life and Congregational Life – to get to the realistic budget that was presented at the Stewardship Luncheon. And I am pleased to report that our pledge totals for 2024 exceed budget(!) for the first time since the onset of Covid! Thank you to everyone who filled out a pledge card! This truly does help Session with the task of overseeing our church finances.

Cathy Rew decided to retire, and we welcome Karen Watson as the new Church Treasurer in 2024. We thank Cathy for her years of service and Karen for her willingness to take on this very important role. Following Cathy's departure, an audit of church accounts will take place in first quarter, 2024.

Lastly, thank you for trusting Session to be a good steward of our church funds as we look ahead to 2024 and continue to "nurture" what is placed before us and give thanks to God for helping us "grow."


Internet

In traffic news, PCBV enjoys an incredible amount of visitors from the USA. Germany still remains firm in second place. The UK bumped Belgium out of third place.





Sanctuary A/V

The Sanctuary A/V system underwent major upgrades in 2023. Most everything but the projectors and roaming microphones were replaced. Due to the generosity of our members, whom we are very grateful for, we were able to upgrade almost our entire system. Notable are the Martin Audio speaker arrays which help spread the sound into once quiet areas of the Sanctuary. The legacy speakers were also removed and the holes patched, leaving a nice minimal aesthetic. Other legacy speakers



that were hung from the ceiling were also removed. New floor standing choir microphones replaced the seven hanging microphones. The pulpit microphone was also replaced.

The massive audio mixing board was consolidated into an iPad Air. The live broadcasting and projection computers were replaced. The light dimmer switches were causing instability issues with the electricity and they were removed. All rack-mounted audio equipment was also replaced.

Thanks to Digital World Audio/Video for their excellent work designing and installing the new audio system.

Canopy

The year started with eleven Deacons. Each Deacon signed up to serve as Deacon of the Month or Back up Deacon to give devotions at the Deacon meeting, work with Pastor Judi McMillian on health needs of members, help serve Home Communion on four Communion Sundays, and attend Session for their month. Other duties included one Deacon representing the Deacons on the Nominating Committee, one on the Bereavement Committee. Susan Foster served as Secretary for the Deacon Meetings.

With the decrease in the congregation, it was decided to have only 10 Deacons starting next year. There will be 3 serving for each class plus one whose main duty will be Moderator.

We started a new Bible study in September titled "Sacred Encounters". To make the lessons more enticing to

members, Pastor Judi has been kind enough to meet with the lesson leaders and offer suggestions on how to

present the lesson so that it has meaning in our lives on a daily basis. The attendance has been very good

and the participation has really improved.

In addition to our monthly Bible study, we have four luncheons each year. The Spring luncheon was held in

March, Birthday Luncheon was held in May, in October the luncheon was to collect for the Thank Offering,

and in December we had our Christmas Tea. At the Christmas Tea we had a speaker from The Children &

Family Advocacy Center in Bentonville. This is one of the local missions the Presbyterian Women support.

Presbyterian Women contribute to 8 local missions serving women and children of NWA. All the funding for

the projects come from the women of the church through pledges. PW has two special collections each year,

the Thank Offering is collected in the fall, and the Birthday Offering is collected in the spring, which supports

projects in Arkansas, around the country, and around the world. The Birthday Offering raised \$765, the Thank Offering raised \$775, Other monies collected for the PW missions were Least Coin (\$242) and Cents

Ability (\$242) which helps raise awareness for the fight against hunger and poverty.

Besides giving money, many of the women participate in Busy Hands with knitting and crocheting scarves,

hats, mittens, baby blankets and lap robes that are sent around the world and Romania for refugees from

Ukraine. Other ladies stay busy making quilts for Ferncliff, Vera Lloyd Home.
